FROM I-95 (NORTHBOUND OR SOUTHBOUND)

Take Exit 13. Turn right at the end of the exit ramp onto US Route 1 (Connecticut Avenue). Turn left onto Richards Avenue at the Shell Gas Station traffic light. Proceed 1/2 mile north on Richards Avenue to NCC. West Campus will be on the left (**course will be on this campus**) East Campus will be on the right.

FROM MERRITT PKWY (CT-RTE 15) NORTHBOUND:

Take Exit 38. Turn right at the end of the exit ramp onto Route 123 South. Take your first left onto Nursery Street. At the stop sign, turn left onto Ponus Avenue. Bear right at the fork onto Fox Run Road. Proceed through the traffic light and follow the road around Fox Run Elementary School. Turn left at the stop sign onto Richards Avenue. Follow Richards Avenue for one mile and the West Campus will be on the right (**course will be on this campus**) and East Campus will be on the left.

FROM MERRITT PKWY (CT-RTE 15) SOUTHBOUND:

Take Exit 38. Turn right at the end of the exit ramp onto Route 123 North. Take your first right onto Nursery Street. At the stop sign, turn left onto Ponus Avenue. Bear right at the fork onto Fox Run Road. Proceed through the traffic light and follow the road around Fox Run Elementary School. Turn left at the stop sign onto Richards Avenue. DIRECTIONS TO CLASSROOM

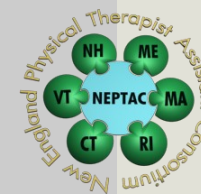
Enter the West Campus through the Center for Information Technology building (door #20). Take the first left and follow the hallway to room W121 (Culinary Arts Dining Room) on the right.

Course Information

This program is recognized by the American Physical Therapy Association (APTA) as the Credentialed Clinical Instructor Program (CCIP) and is being offered by the New England PTA Consortium at the New England Institute of Technology. It takes 16 hours to complete the entire program for CI education and credentialing.

The program addresses issues of planning and preparing for physical therapy and other health profession's students during their clinical learning experiences; developing learning experience and supporting ongoing learning through questioning and effective feedback. A discussion of legal and regulatory issues associated with clinical educators is addressed, including issues presented by ADA legislation. The program closes with developing skills in identifying and managing students with exceptional performance as well as students presenting with problems.

The "Assessment Center", available only to physical therapists and physical therapist assistants, provides the participant with the opportunity to apply information from the program in simulated situations. Successful completion of each station in the Assessment Center results in the awarding of APTA CI Credentialing. The six stations of the Assessment Center have been integrated into the program schedule. Therefore, it is essential for each participant to attend all sessions of the Course and Assessment Center in its entirety.

The Program and Assessment Center will be useful for both new and experienced physical therapist and physical therapist assistant educators involved with clinical education. In addition, the Program is helpful for and available to clinical educators from nonphysical therapy providers based on a solid theoretical foundation. While the information presented covers the basic skills for clinical instructors, the interactive tasks and large & small group discussions will be of benefit even to experienced educators.
